## TRANSPORTATION

Santa Monica Ordinance 1604 requires employers with 50 or more employees to comply by completing a trip or emissions reduction plan. A trip reduction plan requires that you have a Employee Transportation Coordinator (ETC) administering your plan. We offer three packages to help you comply:

**1. ETC Training Only** - If you are interested in developing and implementing your program, you can attend a training session to learn everything you need to know to submit an approvable trip or emissions reduction plan. You can attend:

- Two day training           \$350
- One day training           \$400

**2. Plan preparation and Consultant ETC** - If you select this option, Cara Rice & Associates serves as your Consultant ETC. We conduct the employee survey, tabulate the survey results, calculate the AVR, and prepare the trip reduction plan. If you decide upon this option, **NO ETC TRAINING** is needed. Cost is **\$700**.

**3. Compliance in a Package** - For employers interested in a complete turnkey package, whereby eliminating the need to devote staff resources and time. Our package includes ETC training, employee survey processing, AVR calculation, plan preparation, marketing materials, tracking and monitoring forms, oversight, program evaluation and other off-site support services including a website. Cost is **\$1,800 a year (\$150 a month)**.

## FOOD SAFETY

If you own or operate a restaurant in Los Angeles County, you are required to attend a **Certified Food Handler** training program.
